Summer Program: The summer program provided service-learning experiences for 549 youth, young adult, and adult volunteers, and employed 17 young adult staff. In two partner communities overnight volunteers participated in week-long sessions throughout the Western United States where they completed home improvement projects to improve the safety and livability of homes for lower-income residents. In Del Norte County, volunteers completed 11 home repair projects for tribal members throughout the county, spanning almost 40 miles of coast from Smith River to Klamath including: three sets of stairs, three railing repairs, two exterior paint projects, a porch, an accessibility ramp, and a wood storage shed. Youth and adults also contributed to nine community-based projects at five community gardens, Redwood Parks Conservancy, and our host facility, Crescent City United Methodist Church. In July we celebrated the 10th anniversary of our partnership with the Tolowa Dunes Stewards! Over 2,700 SSP volunteers have invested time in restoring the native ecosystem by removing invasive European beach grass, which the Stewards estimate is valued at over \$250,000. We expanded our partnership in 2023 to include removing invasive English ivy in Jedediah Smith Redwoods State Park. In Chiloquin, OR volunteers completed 11 home repair projects and 3 community projects

Workforce Development: In June 2023 we launched the Sacramento Sustainability Academy (SSA) a workforce development jobs program designed to provide young people an introduction to climate action and community resilience work. Building on SSP's history of providing youth and young adults with hands-on experience with tools, home repairs, and high impact community projects, the Academy is focused on energy efficiency through the lens of building science, urban agriculture as a tool for achieving food security/sovereignty through permaculture design principles, and manufacturing design skills to provide young people high demand and cutting edge skills for high paying professions. All program fellows are required to reside within the city limits of Sacramento, and meet additional requirements. Priority was given to individuals who have difficulty finding employment, are low-income, are unemployed and/or out of school, are or were justice-involved, are in or transitioning from foster care, or are engaged with the mental health or substance abuse system. We hosted two eight-week cohorts in the spring and an additional summer cohort, funded by the City of Sacramento. They were paid above minimum wage to honor their time invested in learning and serving the community. In 2024, we temporarily expanded the workforce development program into Rancho Cordova, funded

Sacramento County Year-Round Programs: SSP hosted 216 year-round volunteers in Sacramento County during Days of Service or Alternative Break sessions. Alternative Break sessions are custom scheduled by group request, and vary from year to year significantly in length and location - all were day only programs this year (not overnight). Our largest Day of Service project was building 1,000' of wood fences for the Dixieanne Clean and Green Alley Project, funded by CalTrans through the City of Sacramento. Crews from Sacramento Regional Conservation Corps and AmeriCorps National Civilian Community Corps made significant contributions to this project, as well as corporate, school, and church groups. The North Sacramento Free Tool Library continued to offer over 100+ tools to our neighbors in the community to borrow for free including power tools, wheelbarrows, stick tools, tables, and chairs. During the 2024 fiscal year, 129 loans were made by 28 users.

in Chiloquin, including: 280' of fencing, three sets of stairs, railing repair, painted a house, 4,000 pounds of material removed from a residence, installed an awning over a ramp SSP built in 2018, repainted bleachers, picnic tables, and front entrance of the rodeo grounds, shed for sports equipment storage at the high school, and a shed for storage at the Chiloquin Cares Food Pantry. One day a week was dedicated to partnering with Oregon State Parks at Collier Memorial State Park. Volunteers removed downed trees and dry brush caused by the 242 Fire in 2020, expanding the day use area accessible for visitors. They also cleared 7,000' of barbed wire to restore wildlife migration routes. In total, SSP volunteers were able to save rangers about 10 weeks of work.
